(FOR EVENTS WITH ANTICIPATED SOUNDS IN EXCESS OF 80 dB's, AN APPLICATION FOR A **SOUND VARIANCE** MUST BE SUBMITTED AT LEAST 21 DAYS PRIOR TO THE EVENT.)

THIS APPLICATION MUST BE SUBMITTED NOT LESS THAN 7 BUSINESS DAYS BEFORE THE EVENT.

By submitting this Application, Applicant(s) acknowledge and agree that he/she/they have read the Village Code section 109-2 excerpts attached regarding excessive sound levels, and that the Village of Hamilton will post prior public notice, including on the Village website, that a Sound Permit has been issued, including the name(s) of the Applicant(s), the address of the event, and other relevant information regarding the event and the permit issued. All sound should always be kept at an acceptable level that will not unduly disturb the surrounding community, regardless of the issuance of a sound permit.
